# III. Purpose of RFQ

## Purpose of the RFQ:

PATH South Africa Project Office based in Rosebank, Johannesburg supports country-based activities for the Digital Square Initiative and Advocacy Public Policy project.

Digital Square works in close partnership with the United States Agency for International Development (USAID)/South Africa and the National Department of Health (NDoH) to strengthen the national health information system and data use in the public sector. Digital Square South Africa is a four-year program designed to address digital health architecture, interoperability, analytics, and reporting needs to strengthen health system performance and specifically improve service provision and performance monitoring for HIV/AIDS and Tuberculosis (TB). Frequent travel to throughout South Africa's provinces is required to advance this work.

The Advocacy and Public Policy project, advocates for evidence-based policies, funding, and program implementation that support the development and uptake of global health technologies, nationally and within the region. PATH holds the role of secretariat for the South African Health Technologies Advocacy Coalition (SAHTAC), and coordinates civil society input into health research and development (R&D) related policy development and implementation. The three-year grant for these activities is funded by the Bill & Melinda Gates Foundation (BMGF).

PATH seeks to engage the services of an executive travel management company to manage their day-to-day bookings of domestic and international flights, accommodation and airport transfer and other ad-hoc travel as required.

The selected bidder should be able to accommodate our robust travel schedule supporting up to 30 people with an average travel spend of R110,000 per month. PATH would request initial credit facility of R160,000 per month for two years.

Given the high volume of travel, PATH is seeking a full-service travel management company to allocate an experienced and responsive account manager who can provide excellent customer service. The manager should be solutions oriented, have extensive knowledge and network of travel services throughout the country. Afterhours support for travelers and a comprehensive plan for customer engagement is required.
