# III. Project Background

# A. Project Background

The Digital Regional East African Community Health (Digital REACH) Initiative has been developed by the East African Community (EAC). Since its inception, a ten-year strategic plan has been developed collectively by the six EAC Partner States (Burundi, Kenya, Rwanda, South Sudan, Tanzania and Uganda) under the coordination of the EAC. The Digital REACH Initiative has been endorsed by the

Presidents and Ministers of Health for resource mobilization and implementation. This information and communications technology (ICT)-driven Initiative has the potential to transform health service delivery and improve health outcomes, while at the same time reducing both capital investment and recurrent cost. Through programs such as regional health cloud, telemedicine, and disease surveillance, the Initiative will allow for data sharing, provision of essential health services to rural and remote areas, and effective regional control of disease outbreaks (e.g., Ebola, Polio, etc.). Furthermore, such programs have the potential to generate revenue through marketable components that could attract private sector investments given the fact that all six EAC Partner States will operate as a single market under the Digital REACH Initiative.

The East African Health Research Commission (EAHRC) is coordinating the Digital REACH Initiative and leverages a wide array of resources in the region as needs arise. This may include the EAC's own institutions, Ministries of Health from its Partner States, and individuals. It is governed by a Council of Ministers of the EAC Partner States who serve as the central decision-making body of the EAC. The EAC Secretariat is the executive organ of the EAC. As the guardian of the Treaty under which the EAC was established, the Secretariat ensures that regulations and directives adopted by the Council are properly implemented. The EAC through its EAHRC has made considerable progress towards the implementation of the Digital REACH Initiative since its initial inception. In addition to the highest-level endorsement of the Partner States, many donors have welcomed the Initiative. In August 2019, EAHRC organized a meeting between donors and senior EAC government representatives with participants from the Bill & Melinda Gates Foundation, the World Bank, USAID, the Rockefeller Foundation, PATH/Digital Square, DIAL, WHO-AFRO, CDC, and others. The meeting resulted in validation of the areas of alignment between country-specific, regional, and donor strategies for digital health. After in-depth discussions on priority workstreams and health programs, attendees collectively selected the following for immediate implementation:

- The East African Health Cloud (EAHC): a regional interoperable health information system that will enable real-time capture, storage, analysis, and retrieval of health data across the EAC Partner States.
- Regional East Africa Disease Control and Response (READSCoR): a digital mechanism for regional disease surveillance, biosecurity, and preparedness for disease outbreaks including prediction, detection, and effective response.
- Telemedicine Networks for East African Tertiary (NEAT): a program under the Universal Health Coverage, aims at improving access to specialized health services to communities living in rural and remote areas. It will link the East African Centers of Excellence for specialized health services with other health and academic facilities across the region.
- Workforce Development: a workstream focused on building capacity of health workers (including community health workers) in the region to facilitate the sharing of human resources and evidence-based health practices across countries.

Digital Square at PATH supports the East Africa Community by serving as a fiduciary agent for the Digital REACH Initiative and consulting on technical issues if and as requested. Digital Square is a partnership of the world's leading digital health experts from 40+ organizations working together with countries to strengthen digital health systems. In pursuit of our Mission: **connect health leaders with the resources necessary for digital transformation**, Digital Square offers a new way to invest in digital health—providing a space where countries and members of the global community can gather to think big and do good, together. By convening government officials, technological innovators, donor and implementation partners, and others across borders and boundaries in the Digital Square, we can grow possibility into

reality by focusing on our common goal: **connecting the world for better health**. Digital Square works in three key ways:

- Co-investment: We coordinate investments in digital health to maximize the impact of every dollar spent.
- Global goods: We scale tools and technologies that can be adapted to different countries and contexts.
- Digital market readiness: We create digital market readiness by building capacity with governments, local technology developers, and health workers.

Through this RFA, Digital Square at PATH seeks partnership with a subrecipient that can second four personnel to the EAC for a four-month period to develop a public-private partnership model, revenue and resource generation models, as well as the detailed technical proposals for four sub-initiatives within the Digital REACH Initiative strategic plan: the East Africa Health Cloud (EAHC); regional telemedicine network; disease surveillance; and workforce development.

# B. Proposed Project Timeline

PATH anticipates the subaward duration with be a four-month period and end by September 30, 2020. As part of Digital Square's due diligence, we will conduct pre-award evaluations of all shortlisted candidates. We will use our recipient pre-award survey, informed by USAID's non-US organization pre-award survey (NUPAS) and other industry-wide standards, and customized for Digital Square. In addition to project-specific deliverables based on individual scopes of work, PATH will require applicants to provide, at minimum, quarterly narrative and financial reports to support their work.

# IV. Scope of Work and Deliverables

## A. Scope of Work

On behalf of the EAC, Digital Square seeks interested firms that can offer secondments of four personnel to the EAC for a 4-month period. The secondees will be tasked with the development of a public-private partnership model, revenue and resource generation models, as well as the detailed technical proposals for the EAHC; regional telemedicine network; disease surveillance; and workforce development. The work will include conducting detailed (baseline and needs) assessments in the EAC Partner States; assessing the EAC data center at the EAC Headquarters and suggesting ways to strengthen it for the Digital REACH Initiative; providing the EAC with options for cloud hosting and a process for migrating common goods from EAC Partner States onto the EAHC; and developing detailed technical proposals for regional telemedicine network, regional disease surveillance system, and a workforce development plan.

Developing a sound investment case and revenue generation model will be key in helping countries understand the value proposition of a regional approach to digital health. Specific components of the value proposition include common regional hosting services, data sharing, regional diseases surveillance system, and access to specialized health services by communities living in rural and remote areas. One resource that the Initiative anticipates using and supporting is the East Africa Health Portal. The Portal is the official comprehensive compendium of health information in East Africa and will be a critical platform to support multiple Digital REACH initiatives.

The support requested aims to build the foundation through which the programs under Digital REACH Initiative will become an integral part of the respective EAC national health systems that are linked to one another at the regional level. There is a clear opportunity for East Africa to utilize digital technologies to advance the health and prosperity of the region and its citizens in ways that are more effective and efficient. Open borders and the continuous movement of people underscore the need for a regional approach to track and respond to regional health priority needs, while laying the groundwork for a robust and sustainable regional economy. Technology can help to strengthen regional health systems by

bolstering the access, use, and performance of health services. Each of the Digital REACH Initiative workstreams support the EAC's integration agenda of "One People, One Health System." This support of regional integration is what makes the Digital REACH Initiative unique and is why it has received the highest levels of political support in the EAC region. Strengthening healthcare provision at all levels of the health system, from national all the way to the regional level, is critical to regional health security and to facilitate access to quality healthcare across the region.

It is anticipated that over time the programs under the Digital REACH Initiative will generate their own revenue (e.g., East Africa Health Cloud, telemedicine) and therefore will be self-sustaining under their respective national health system and regional health system at large. As part of this body of work, the EAHRC with support from Digital Square will develop a sustainability plan based on further identification of marketable components identified in the project, as well as through discussions with private sector stakeholders.

# V. Application Requirements - Cost

The magnitude of the requirement for this application is approximately \$200,000 USD. This amount is just an estimate provided for informational purposes to the offerors and is not binding.

The applicant should provide a detailed explanation of costing and describe the reasonableness of each proposed cost in the budget narrative.

Digital Square will evaluate the quoted prices and hourly rates. No analysis will be performed on quotes determined as non-responsive or if the technical quote is determined to be technically unacceptable. The price/business evaluation will be conducted in accordance with the quoted utility-based solution and proposed labor categories, their rates and Evaluation Matrix. Digital Square will conduct an analysis to determine if all quoted prices are reasonable. This evaluation is conducted with the expectation of adequate price competition and will rely heavily on market forces to determine whether proposed prices are fair and reasonable. The comparison of proposed prices in response to this solicitation is the preferred and intended price analysis technique.

Digital Square will also compare the proposed prices to historical prices paid for the same or similar services and the independent government cost estimate. Other techniques and procedures may be used to ensure quoted prices are fair and reasonable. A cost realism analysis will be performed to determine whether the quoted Level of Effort is realistic for the work to be performed, reflects a clear understanding of the requirements and is consistent with the unique methods of performance set forth in the applicant's technical quote.

# A. Required Elements

The Cost Application must include a budget narrative, detailing the cost and cost basis applied in generating the application. The Cost Application must also include a detailed budget that is itemized along the cost categories defined below. This detailed budget should be submitted in an unlocked Excel spreadsheet and must include the following information:

- Personnel at minimum the budget should detail:
  - All proposed staff/positions with daily rates.
  - o Total number of days in total level of effort according to key staff.
- Itemization of all other costs (e.g., agency costs, service tax, administrative costs, supplies, etc.).
- Estimated schedule of other anticipated expenses (travel, subawardee resources, supplies, outside resources, etc.).
- Details of all subcontracted work, this includes proposed consultants as well as proposed subawardees.

## B. Special Note on Indirect Costs

# B. Confidentiality

All information provided by PATH as part of this solicitation must be treated as confidential. In the event that any information is inappropriately released, PATH will seek appropriate remedies as allowed. Applications, discussions, and all information received in response to this solicitation will be held as strictly confidential, except as otherwise noted.

### C. Conflict of interest disclosure

Applicants bidding on PATH business must disclose, to the procurement contact listed in the RFA, any actual or potential conflicts of interest. Conflicts of interest could be present if there is a personal relationship with a PATH staff member that constitutes a significant financial interest, board memberships, other employment, and ownership or rights in intellectual property that may be in conflict with the applicant's obligations to PATH.
